TPS: STATEMENT ABOUT THE TREASURY STOCK BUYBACK PROGRAMME

Gallarate (VA), 23th October 2023 – TPS S.p.A. ("**TPS**" or the "**Company**" or "**Issuer**"), operational holding company of the TPS Group, *leader* in the technical services and engineering sector for the aeronautical and automotive industries, hereby states that, between 16th and 20th October 2023, purchased 8,000 treasury stock at a weighted average price of Euro 5.284 per share, for a total countervalue of Euro 42,275, as part of the treasury stock buyback programme, approved by the ordinary shareholders' meeting of 28th April 2023 and commenced after the Board of Directors of 29th June 2023.

The purchase process of treasury stock has been coordinated by MIT Sim S.p.A, as a qualified intermediary entrusted to carry out operations in accordance with the terms and conditions conferred by the Board of Directors of the Company.
